Ordinance No.12-03

An Ordinance annexing to the Village of Williamsfield a contiguous territory owned by

WAS LAND TRUST

WHEREAS, pursuant to 65 ILCS 5/7-1-8, any territory which is not within the corporate limits of any municipality but which is contiguous to a municipality at the time of annexation and meets all other statutory requirements may be annexed to the Village of Williamsfield; and

WHEREAS, real estate described as follows:

Parcel Identification Number: 12-26-200-011

Part of Lots 2 and 3 of the 1893 Subdivision of the Northwest Quarter of the Northeast Quarter of Section 26, Township 11 North, Range 4 East of the Fourth Principal Meridian, Knox County, Illinois, and being more particularly bounded and described as follows:

Commencing at the Northwest corner of the Northeast Quarter of said Section 26; thence S00°20'59" E, along the West line of the Northeast Quarter of said Section 26, a distance of 330.69 feet to the Northwest corner of said Lot 2; thence N 89°40'27" E, along the North line of said Lot 2, a distance of 50.07 feet to the East Right-of-Way line of Illinois Route 180 and the point of beginning of the tract of land to be described; from the point of beginning, thence N 89°40'27" E, continuing along the North line of said Lot 2, a distance of 612.25 feet to the Northeast Corner of said Lot 2; thence S 00°27'18" E, along the East line of said Lots 2 and 3, a distance of 330.69 feet; thence S 89°40'27" W, a distance of 613.59 feet to the Right-of-Way line of Illinois Route 180; thence N 00°13'25" W, along said Right-of Way line, a distance of 330.69 feet to the point of beginning and containing 4.6530 acres, more or less.

WHEREAS, The Board of Trustees of said Village has considered the question of the annexation of said real estate and finds it to be for the best interests of said Village and the inhabitants thereof that said real estate be annexed to said Village;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES of the Village of Williamsfield located in the County of Knox and the State of Illinois;

SECTION 1: That the real estate hereinabove described which is not within the corporate limits of any municipality but is contiguous to the Village of Williamsfield be and the same hereby is annexed to said the Village of Williamsfield;

SECTION 2: This Ordinance shall be in full force and effect from and after its passage.
