**ORDINANCE NO. 2023-11**

AN ORDINANCE LEVYING AND ASSESSING TAXES FOR THE FISCAL YEAR COMMENCING MAY 1, 2023 AND ENDING APRIL 30, 2024.

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS:**

**SECTION 1:** That a tax for the following sums of money, as set forth below, or as so much thereof as may be authorized by law to defray all necessary expenses and liabilities of said Village of Williamsfield, be and the same is hereby levied from the sources indicated and for the purposes specified, against all taxable property in the Village, for the fiscal year commencing on the 1st day of May, 2023, and ending on the 30th day of April, 2024.

**I. GENERAL FUND (AKA CORPORATE FUND)**

Total Estimated Expenditures to be covered by General Corporate Levy: \$20,000.00

Said amounts are hereby levied as the General Corporate Fund Tax (65 ILCS 5/8-3-1)

**II. POLICE PROTECTION**

Total Estimated Expenditures to be covered by Special Levy: \$5,600.00

Said amounts are hereby levied as the Police Protection Tax (65 ILCS 5/11-1-3; 5/11-1-5.1)

---

**III. AUDIT FUND**

Total Estimated Expenditures to be covered by Special Levy: \$3,900.00

Said amounts are hereby levied as the Municipal Auditing Tax (65 ILCS 5/8-8-8)

---

**IV. LIABILITY INSURANCE FUND**

Total Estimated Expenditures to be covered by Special Levy: \$4,100.00

Said amounts are hereby levied as the Liability Insurance Fund Tax (745 ILCS 10/9-107)

---

**V. FICA (SOCIAL SECURITY) FUND**

Total Estimated Expenditures to be covered by Special Levy: \$16,670.00

Said amounts are hereby levied as the Social Security Fund Tax (40 ILCS 5/21-110)

---

VI. STREET LIGHTING FUND

Total Estimated Expenditures to be covered by Special Levy: \$3,760.00

Said amounts are hereby levied as the Street Lighting Tax (65 ILCS 5/11-80-5)

**SECTION 4:** This Ordinance shall be in full force and effect upon its adoption, approval and publication as provided by law.

**SECTION 5:** Certified copies of this Ordinance shall be filed with the County Clerk of Knox County within 30 days after adoption but no later than the last Tuesday in December, 2023.




