ORDINANCE NO. 1986-1

AN ORDINANCE AMENDING THE SALE OF INTOXICATING LIQUORS ORDINANCE  
OF THE VILLAGE OF WILLIAMSFIELD

BE IT ORDAINED by the President and Board of Trustees of the  
Village of Williamsfield, Illinois:

SECTION 1: LICENSE REQUIRED: It shall be unlawful to sell or  
offer for sale at retail in the Village any alcoholic liquor with-  
out having a retail liquor license. There may be a maximum of two  
retail liquor licenses issued in the Village of Williamsfield.

SECTION 2: LICENSE FEE: The annual fee shall be \$1,000.00.

SECTION 3: HOURS: The hours for all establishments selling  
alcoholic beverages shall be 6:00 a.m. to 12:00 p.m. Monday through  
Saturday. These hours shall mean that the doors of the premises  
shall be locked at the twelve o'clock closing time and no customers  
shall be in the premises after the twelve o'clock closing time.  
No sale or consumption of alcoholic beverages in the premises  
shall be allowed after twelve o'clock.

SECTION 4: PRESENCE OF PERSONS OF NONAGE UPON LICENSED PREMISES:

A. No person under the age of twenty-one shall be per-  
mitted on a premise licensed pursuant to this Ordinance  
between the hours of 7:00 p.m. and 6:00 a.m.

B. Age twenty-one reflects the Illinois state law  
establishing the legal age for consumption of alcoholic  
liquor. This Ordinance shall be modified automatically to  
reflect state changes, if any, in the legal age for  
consumption of alcoholic liquor.

SECTION 5: REGULATIONS:

A. No person, operating or conducting the sale of  
alcoholic liquor under a license, shall serve or permit to be  
served any alcoholic liquors of any kind in any portion of the  
premises the interior of which is shut off from the general  
public view of doors, curtains, screenings, partitions or  
other devices of any kind, and no such private area may be  
maintained as part of or adjacent to any establishment  
operating under a retail liquor license.

B. It shall be unlawful for any person to carry any  
alcoholic liquors in any unsealed or open container from the  
licensed premises where such alcoholic liquor was purchased.

No licensee or person as proprietor, agent, servant  
or employee of such licensee shall knowingly permit any patron

to violate this paragraph not to continue to sell alcoholic liquors to such person knowing that such person intends to carry the alcoholic liquor from the premises in an open or unsealed container.

C. For the purpose of this Section of this Ordinance, "premises" as herein used in this Ordinance and this Ordinance as amended, is defined as "that area within a building for which a license to sell alcoholic liquor is issued and which is actually used in the connection with the storage, preparation and sale of alcoholic liquor, but specifically excluding any outside areas such as patios, open porches, rooftops, balconies, stoops, sidewalks, yards, driveways, parking lots and similar outside areas."

D. Each licensee and each of his agents and/or employees shall promptly report to the Police Department of the Village of Williamsfield any incident occurring on or about the licensed property and in his knowledge or view relating to the commission of any crime, including but not limited to any violation of this Ordinance as amended, and including but not limited to any fighting, batteries, or assaults, and shall truthfully and fully answer all questions and investigations of any identified police officer who makes inquiry concerning any person in or about the licensed premises and any events taking place in and about the licensed premises.

E. No licensee or any officer, associate, member, representative, agent or employee of such licensee shall engage in any activity or conduct or suffer or permit any other person to engage in any activity or conduct in or about the licensed premises which is prohibited by any ordinance of the Village of Williamsfield or statute of the State of Illinois or of the United States of America.

SECTION 6: ENFORCEMENT: The Mayor or President of the Board of Trustees shall be the local liquor control Commissioner and shall be charged with the administration of this Ordinance and other such ordinances, acts and resolutions relating to alcoholic liquors as may be enacted.

The local liquor control Commissioner may revoke or suspend the retail liquor dealer's license for violations of any provisions of the State Act, any valid ordinance or resolution or applicable rules or regulations established providing:

A. A public hearing shall be held by the local liquor control Commissioner.

B. The licensee shall be given a three-day written notice to appear and defend.

C. Within five days after the hearing, the Commissioner shall state the reason or reasons for his determination in a written order of revocation or suspension.

D. A copy of such order shall be served upon the licensee within the same five days.

E. Within a period of twenty days after receipt of such order the licensee shall have the privilege of appealing the order to the State Liquor Control Commission.

SECTION 7: All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed. This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
