President Matt Tonkin was absent due to out-of-state travel and Trustee Nancy Everett filled in as pro-tempore. Financial Statements: Motion by Trustee Self and seconded by Trustee Scott to approve the financial statements. All in favor. Motion carried.

Public Comment: NA

Correspondence: Trustee Everett received a survey from Great Lakes Community Partnership regarding James Meece who assists with applying for grants.

Streets and Maintenance Report: Trustee Scott stated Eric Mitchell is a consultant from Core and Main that is going to take inventory of stock items at the maintenance shed, suggest items to order to have on hand and identify obsolete items. There are 3 hydrants on the East end of town that need to be checked and possibly replaced, Trustee Scott questioned if hydrants were included in the second water phase. The GMC dump truck heat guit working and the thermostat is obsolete; the Board had discussed trading in or selling both Village trucks and getting a 1-ton 4x4 truck with a dump bed and plow, it would save on maintenance costs and insurance. The mower tractor used for sidewalk plowing had a wheel motor go bad. There was a water main break on Gale Street on Christmas Eve and the Village's backhoe would not cut through the frost and the borrowed backhoe from Ed Lewis also struggled. President Tonkin asked Trustee Scott and the maintenance department to make a list of priorities on items that need completed; #1 new truck, #2 maintenance shed, #3 backhoe upgrade and #4 new mower tractor. The Village will save \$2500 a year once the leased building from the railroad is cancelled. Trustee Scott stated the maintenance department has a map of sidewalks and roads in need of repair, they want to make sure summer help is lined up and trained to complete the sidewalks in the summer. The storm water study is on hold; the USDA Grant requests an engineering report that costs \$34,0000; Trustee Everett is in contact with "local roads" for assistance. The alley behind Double Take and next to the Food Pantry has not been vacated; Massie's could possibly create/amend an ordinance declaring the ally not for public use/no motorized vehicles allowed.

Water Report: Trustee Everett stated there have been quite a few bidders for the second water phase. Tom Rice stated there were a few minor problems at the RO Plant due to the cold weather; he ordered 12 boxes of filters that are hard to get so he is stocked up. The boil order is still in effect.

Motion by Trustee Scott and seconded by Trustee Self. All ok. Motion carried.

Old Business: President Tonkin is going to reach out to the contractor to find out when the water tower will be cleaned. Water projects lead to lead in the water; there is a slim chance but it is possible, the Board will follow up with Bruner, Cooper and Zuck. KP Hall grant paperwork is being submitted for final payment. The board discussed advertising for someone to clean the KP Hall once a month.

New Business: September 2023's meeting will be held Tuesday, September  $5^{th}$  due to Labor Day.

Motion by Trustee Self and seconded by Trustee Scott to adjourn the meeting. All were in favor.
