AN ORDINANCE AMENDING ORDINANCE NUMBER 20019-02 OF THE VILLAGE OF WILLIAMSFIELD ENTITLED ‘AN ORDINANCE TO ESTABLISH RULES, RATES REGULATIONS FOR THE OPERATION OF THE VILLAGE OF WILLIAMSFIELD WATER SYSTEM AND GARBAGE AND RECYCLABLE COLLECTION.’

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS AS FOLLOWS:

Section 10 Entitled “Garbage and Recyclable Collection” of Ordinance Number 2019-02 of the Village of Williamsfield Entitled “An Ordinance to Establish Rules, Rates Regulations for the Operation of the Village of Williamsfield Water System and Garbage and Recyclable Collection” shall be amended as follows:

SECTION 10. Garbage and Recyclable Collection. All users of water and sewer service within the Village limits and outside the Village limits as approved by the Board of Trustees shall be required to pay the monthly service charge for garbage and recyclable collection whether or not they use said service. All apartments and mobile homes shall be considered users. The owner of the premises, the occupant thereof, and the user of the service shall be jointly and severally liable to pay for the service of such premises and the service is furnished to the premises by the Village only upon the condition that the owner of the premises, occupant and user of the service are jointly and severally liable therefore to the Village. The service charges for users of the refuse collection system of the Village shall be as follows:

- A. The monthly fee shall be \$10.00 per household for garbage collection for May 1, 2021 to April 30, 2022.
- B. The monthly fee shall be \$10.50 per household for garbage collection starting May 1, 2022 to April 30, 2024.
- C. The monthly fee shall be \$5.65 per household for recyclable collection for May 1, 2021 to April 30, 2022.
- D. The monthly fee shall be \$5.82 per household for recyclable collection starting May 1, 2022 to April 30, 2024.

This Ordinance shall be in full force and effective beginning May 1, 2021, upon its passage, approval and publication as provided by law.


All ordinances or parts of Ordinance in conflict herewith are hereby expressly repealed.


