ORDINANCE NO. 77-1

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS (THE RUSSELL J. POTTER - WILLIAM R. BYCROFT PROPERTY)

WHEREAS, a written petition, signed by the legal owners of record of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Williamsfield, Knox County, Illinois, requesting that said territory be annexed to the Village of Williamsfield; and,

WHEREAS, there are no other electors residing within the said territory; and,

WHEREAS, the said territory is not within the corporate limits of any municipality, but is contiguous to the Village of Williamsfield; and, as any said the contiguous to the village of williamsfield;

WHEREAS, legal notices regarding the intention of the Village to annex said territory have been sent to all public bodies required to receive such notice by State statute; and,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND WOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: THAT the following described territory:

The East 200 feet of the North 262.8 feet of the Northwest
One-quarter (%) of Section Twenty-six (26), Township Eleven
(11) North, Range Four (4) East of the Fourth Principal
Meridian, situated in the County of Knox, State of Illinois.

being indicated on an accurate map of the annexed territory, (which is appended to and made a part of this Ordinance) is hereby annexed to the Village of Williamsfield, Knox County, Illinois.

Section 2: THAT the Village Clerk is hereby directed to record with the Recorder of Doeds and to file with the County Clerk a certified copy of this Ordinance, together with the accurate map of the territory annexed appended to said Ordinance.

Section 3: THAT this Ordinance shall be in full force and effect from and after its passage.
