

ORDINANCE NO. 2024-01

AN ORDINANCE OF THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY,
ILLINOIS AMENDING ORDINANCES 2019-02 AND 2021-02 REGARDING RATES
AND RULES FOR GARBAGE AND RECYCLABLE COLLECTION

BE IT ORDAINED by the President and Board of Trustees of the Village of Williamsfield, Knox County, Illinois as follows:

Section 1: Section 10 entitled "Garbage and Recyclable Collection" of Ordinance Number 2019-02 of the Village of Williamsfield entitled "An Ordinance to Establish Rules, Rates Regulations for the Operation of the Village of Williamsfield Water System and Garbage and Recyclable Collection," as amended by Ordinance Number 2021-02, shall be further amended, such that said Section 10 shall henceforth provide as follows:

SECTION 10. Garbage and Recyclable Collection. All users of water and sewer service within the Village limits and outside the Village limits as approved by the Board of Trustees shall be required to pay the respective monthly service charges for garbage and recyclable collection services whether they use said services. All apartment units and mobile homes shall be considered users. The owner(s) of the premises, and the occupant(s) thereof, and the user(s) of the services shall be jointly and severally liable to pay for the services to such premises, and the services are furnished to the premises by the Village only upon the condition that the owner(S) of the premises, occupant(s) of the premises, and user(s) of the services are jointly and severally liable therefore to the Village. The service charges for garbage collection and recyclables collection shall be as follows:

Garbage Collection Services

From May 1, 2024 through April 30, 2025: \$11.50 per month per household.
From May 1, 2025 through April 30, 2026: \$12.00 per month per household.
From May 1, 2026 through April 30, 2027: \$12.50 per month per household.
From May 1, 2027 through April 30, 2028: \$13.00 per month per household.
Thereafter, \$13.00 per month per household or such higher rate set by the Village Board.

Recyclables Collection Services

From May 1, 2024 through April 30, 2025: \$5.99 per month per household.
From May 1, 2025 through April 30, 2026: \$6.17 per month per household.
From May 1, 2026 through April 30, 2027: \$6.36 per month per household.
Thereafter, \$6.36 per month per household or such higher rate set by the Village Board.

Regardless of whether the above fees are paid and current, the following will not be collected by the Village:

- a. Garbage, refuse or recyclables that is not stored within a can or bag.
- b. Garbage or refuse in excess of a six bag limit, or 3 garbage cans of 63 gallons or less, per month.


- c. Non-recyclables placed in a container reserved for recyclables.
- d. Tires.
- e. Batteries.
- f. Appliances.
- g. Digital devices (including, but not limited to, televisions, microwaves, computers, DVD players).
- and h. Hazardous items, including, but not limited to, dangerous chemicals or biohazardous materials.
- i. Automobile or truck parts.
- j. Landscaping waste (including, but not limited to, tree limbs, brush, grass clippings, leaves, or the like).
- k. Liquids (including, but not limited to, paint, oil, fuel, and grease).
- l. Items over five feet in length.

Section 3: This Ordinance is in addition to all other ordinances on the subject and shall be construed therewith excepting as to that part in direct conflict with any other ordinance, and, in the event of such conflict, the provisions hereof shall govern.

Section 4: This Ordinance is hereby ordered to be published in pamphlet form by the Williamsfield Village Clerk and the Village Clerk is hereby ordered to keep at least three (3) copies hereof available for public inspection in the future and in accordance with the Illinois Municipal Code.

Section 5: This Ordinance shall be in full force and effect upon its adoption, approval and publication as provided by law, provided further, nothing in this paragraph shall be construed as making the rate increases set forth herein effective before May 1, 2024.
