

Notice of Proposed Annexation of Territory Within the Williamsfield Fire Protection District To the Village of Williamsfield

being all of the Trustees of the Williamsfield Fire Protection District, Knox County, Illinois.

You and each of you are hereby notified that the Village of Williamsfield, County of Knox, is about to annex the territory hereinafter described pursuant to the provisions of Article 7, Division 1 of the Illinois Municipal Code (Chapter 24, Illinois Revised Statutues) and that such annexation will take place not less than 10 days after the service of this notice upon you. Said real estate tracts are described as follows:

Tract 1 owned by Robert F. and Zella Mackie:

The South 3/4 of the East One Half (E½) of the Southwest Quarter (SW½) of Section 14, Township 11 North, Range 4 East of the Fourth Principal Meridian, Knox County, Illinois, containing 60 acres more of less, subject to the rights for public highway purposes as conveyed by the Grantors by Deed dated November 17, 1932, and filed for record with the Recorder of Knox County, Illinois, on January 19, 1933, and entered as Document No. 336449.

Tract 2 owned by Howard O. and Frances L. Pierson:

Part of the North Half of the Northeast Quarter of the Southwest Quarter of Section Fourteen (14), Township Eleven (11) North, Range Four (4) East of the Fourth Principal Meridian, more particularly bounded and described as follows, to-wit: Commencing at the Northeast corner of the Southwest Quarter of said Section Fourteen (14) and running thence in a Southerly direction along the West side of the State Highway that runs North and South through the center of said Section Fourteen (14), Twenty-one and One-fourth (214) rods to the place of beginning of the tract to be described; thence continuing in a Southerly direction along the West side of said State Highway to the Southeast corner of the North Half of the Northeast Quarter of the Southwest Quarter of said Section Fourteen (14); thence Westerly along the Southerly line of the North Half of the Northeast Quarter of the Southwest Quarter of said Section Fourteen (14), One Hundred Sixty-six (166) feet to a point; thence Northerly along a line parallel with the West side of said State Highway to a point One Hundred Sixty-six (166) feet West of the place of beginning; thence East One Hundred Sixty-six (166) feet to the place of beginning, situated in the County of Knox and State of Illinois.

The North Half of the Northeast Quarter of the Southwest Quarter of Section Fourteen (14), Township Eleven (11) North, Range Four (4) East of the Fourth Principal Meridian, excepting 1.73 acres, more or less, described by metes and bounds as follows: Commencing at the Northeast Corner of the Southwest Quarter of Section Fourteen (14), and running thence in a Southerly direction along the West side of the State Highway that runs North and South through the center of said Section Fourteen (14), Twenty-one and one-fourth

Brown and wife; the tract conveyed hereby containing 38 acres, more or less, situated in Township Eleven (11) North, Range Four (4) East of the Fourth Principal Meridian, situated in the County of Knox and State of Illinois.

A part of the Northwest Quarter of the Southeast Quarter of Section Fourteen (14), Township Eleven (11) North,

Range Four (4) East of the Fourth Principal Meridian, more particularly bounded and described as follows:

Beginning at a point on the Easterly line of the State Highway running along the West side of said tract, which said point is 40 feet Northerly of the point of intersection of the Easterly line of said highway with the South line of the above-described tract; thence running Northerly along the Easterly line of said highway, a distance of 208 feet and 8 inches; thence East 208 feet and 8 inches; thence South 208 feet and 8 inches to a point 40 feet North of the South line of the above-described tract; thence West 208 feet and 8 inches to the place of beginning; together with the right to use the strip of land adjoining this tract on the South, being 40 feet North and South and 208 feet and 8 inches East and West, for a driveway; SUBJECT to certain restrictions as to usage incorporated in the deed whereby first parties obtained title thereto; situated in the County of Knox, in the State of Illinois.
