BE IT ORDAINED BY THE PRESIDENT OF AND BOARD OF TRUSTEES OF THE  
VILLAGE OF WILLIAMSFIELD, WILLIAMSFIELD, ILLINOIS:

WHEREAS, VERA E. STODGEL and GEORGE L. DOUBET have filed a verified  
Petition dated February 23, 1973 with the Village Clerk, requesting the  
annexation of certain territory to the VILLAGE OF WILLIAMSFIELD, and

WHEREAS, the territory is described as:

TRACT I.

The West 320 feet of Lot One (1) of the Subdivision of the  
Northwest Quarter of the Northeast Quarter of Section Twenty-  
six (26), Township eleven (11) North, Range Four (4) East of  
the Fourth Principal Meridian, according to a Plat recorded  
in Volume one of Plats, Page 87, Knox County, Illinois.

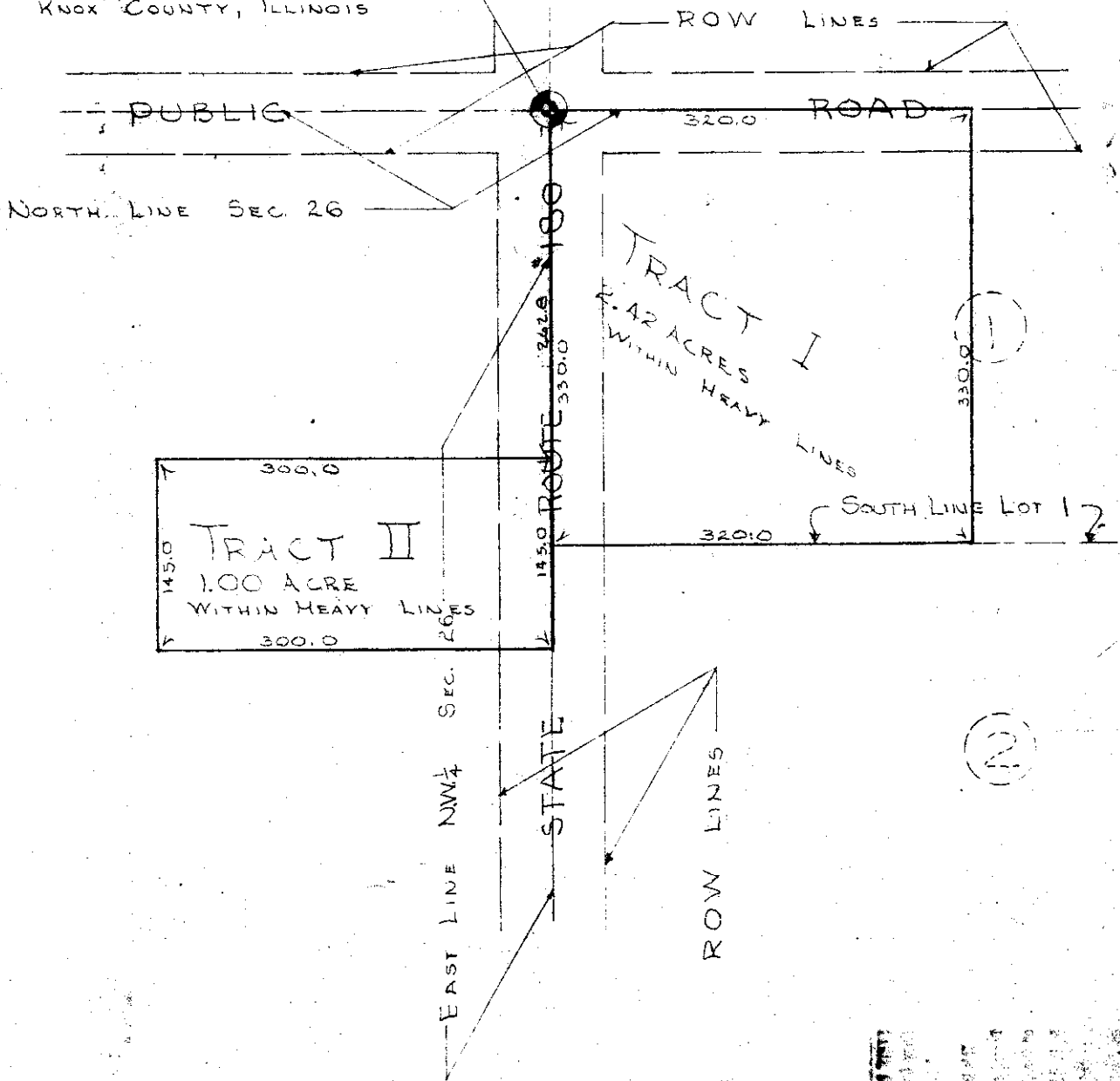
