

AN ORDINANCE PROHIBITING MOBILE HOMES AND TRAILERS
IN THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE
VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. For the purposes of this ordinance certain terms
and words are hereby defined:

Mobile Home - A portable or relocatable prefabricated structure,
in contradistinction to "structure" (hereinafter defined),
or vehicle designed and constructed to be moved on its own
chassis and without a permanent foundation, whether or not
a permanent foundation is subsequently provided, and which
contains sleeping accommodations, flush toilet, tub or
shower bath, kitchen and cooking facilities, and plumbing
and electrical connections for attachment to outside
systems which permit residential occupancy by one or more
persons, and which does not exceed fourteen (14) feet in
width, excluding expandable and retractable components
designed to increase area, or facilitate transporting,
and not in excess of eighty (80) feet in length. For the
purposes of this ordinance, removal of the wheels, hitch
and tongue shall not alter the basic character of a
mobile home.

Structure - Anything constructed or erected, the use of which
requires permanent location on the ground or attached to
something having a permanent location on the ground and
including, but not limiting the generality of the fore-
going, advertising signs, billboards, backstops for tennis
courts and pergolas.

Trailer - A vehicle equipped for use as a dwelling and designed
to be hauled along a highway or public street.

Section 2. No mobile homes or trailers may be located in the
Village of Williamsfield, with the exceptions provided in Section 3.

Section 3. Trailers may be kept in the Village of Williamsfield
provided no utilities are hooked to the trailers and provided the
trailers are not occupied as a residence.

Section 4. This ordinance shall be in full force and effect
immediately upon its passage, approval and publication as provided
by law.

Section 5. Any ordinance or part of ordinance in conflict
herewith is hereby repealed.

Section 6. Any person, firm or corporation violating any provision of this article shall be fined not less than fifty dollars nor more than one thousand dollars for each offense and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.
