

VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS

ORDINANCE NO. 2000-2

AN ORDINANCE VACATING THE ALLEY LYING EAST OF LOTS 7, 8, 9, 10, 11 AND 12 IN BLOCK 2 AND LYING WEST OF LOTS 13, 14, 15, 16, 17, AND 18 IN BLOCK 2, SITUATED IN THE ORIGINAL VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS

WHEREAS, a petition was filed on December 15, 1999, with the Village Clerk of the Village of Williamsfield, requesting the vacation of the alley lying East of Lots 7, 8, 9, 10, 11 and 12 in Block 2 and lying West of Lots 13, 14, 15, 16, 17, and 18 in Block 2, situated in the incorporated area of the Village of Williamsfield; and

WHEREAS, a Notice of Public Hearing to be held on January 3, 2000, considering the vacation of said alley was published in the *Williamsfield Times* on December 23, 1999; and

WHEREAS, the hearing on January 3, 2000, established that vacation of the above described property is in the public interest;

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMSFIELD, KNOX COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the alley lying East of Lots 7, 8, 9, 10, 11 and 12 in Block 2 and lying west of Lots 13, 14, 15, 16, 17, and 18 in Block 2, situated in the Original Village of Williamsfield, Knox County, Illinois, be and the same is hereby vacated; subject, however, to all existing easements for utilities, tile lines and drainage. A plat depicting said property is attached hereto and made a part of this Ordinance.

SECTION 2: The Owners of the adjoining properties are required to provided payment for all publication and recording costs and legal fees incurred.

SECTION 3: That title to the vacated alley shall be and is hereby vested as follows:

1. The West Half of the alley lying adjacent to Lots 7, 8, 9, and 10 in Block 2, subject to all restrictions above stated, shall be and is hereby vested in RICHARD M. SECRIST and PEGGY D. SECRIST, husband and wife, as joint tenants;

2. The East Half of the alley lying adjacent to Lots 15, 16, 17, and 18 in Block 2, subject to all restrictions above stated, shall be and is hereby vested in JERRY A. LADD;

3. The alley between Lots 11 and 12 and Lots 13 and 14 in Block 2, subject to all restrictions above stated, shall be and is hereby vested in RICHARD M. SECRIST and PEGGY D. SECRIST, husband and wife, as joint tenants;

SECTION 4 - EFFECTIVE DATE: This ordinance shall become effective as of the date of its passage, approval and publication in book and/or pamphlet form.

UPON A MOTION duly made by Trustee Robert H. Smith, and seconded by Trustee Robert H. Smith, this Ordinance was passed by the affirmative vote of at least three-fourths (3/4) of the Board of Trustees present for voting; there were cast 5 votes for the Ordinance, 0 votes cast against the Ordinance, and 0 votes cast against the Ordinance, and 0 votes were abstained. 1 member(s) were absent, and there was a quorum present to conduct business on this 3 day of January, 2000.
